Lunches will not only be free to all Hainesport Township School District students, but also any child aged 18 and under who is domiciled within the district is eligible. Just include them on your meal request form. Meal pick ups will be on Wednesdays from 11:00am-12:30 in the afternoon. You will be able to receive up to 7 meals at a time per child. We will also be looking into meal delivery in the future to make it easier on families.
