The New Jersey Student Learning Assessment (NJSLA) for English Language Arts and Mathematics is scheduled to begin Monday, May 5th for Grades 3-8. Additionally, all students in Grades 5 and 8 must be administered the New Jersey Student Learning Assessment-Science (NJSLA-S) Spring 2025 assessment. The NJSLA-S is scheduled to begin Tuesday, May 13th for Grades 5 and 8. Please refer to the chart below for unit testing times. Make-up testing will follow regular NJSLA administration.

**Students enrolled in Algebra I will participate in the 2024 Algebra I unit testing and not the Math unit testing. Therefore, students will complete two units; 90 minutes each and not 3 units.*

Students in grades 3-8 will begin testing following homeroom. Please be sure that your child arrives at school on time on the specified grade level testing dates. Once testing is in session, students arriving late are not permitted to join the testing session, and a make-up date will be scheduled.

Students may bring headphones or earbuds that they are comfortable using to school on the dates of their testing. Additional headphones and earbuds will be available. Please have your child get a good night's rest so they are mentally at their best. Also, please try to have your child eat a healthy breakfast.
